- *The Frontenac Recreation Board, USD 249, and the City of Frontenac assume no liability for injuries or accidents that may arise at the Center.*
- Exercise equipment must be used in accordance with the manufacturer's specifications.
- Use exercise equipment at your own risk.
- Each member must scan their key card to gain access to the Recreation Center. No guests are allowed access through use of a member's card.
- Limit use to twenty (20) minutes per machine if another person is waiting to use the same equipment.
- No one under the age of 18 can use equipment or be in the Recreation Center.
- Food and/or tobacco products are prohibited.
- No glass bottles of any kind are permitted.
- No cameras or digital recording devices in addition to the installed security cameras are permitted on the premises.
- Members must wipe down equipment after use.
- Proper footwear must be worn when using equipment. Sandals and open toed shoes are not to be worn while using the equipment.
- Members must wear proper active wear clothing. Swimsuits are not allowed.
- Members will refrain from using profane language.
- The City, USD 249, and the Frontenac Recreation Board retain the right to enforce, add, or change the Rules and Regulations at any time.
- Failure to conduct yourself in accordance with the above stated Rules and Regulations may result in the loss of the privilege to utilize the Frontenac Public Recreation Center.
